



 - 2.1 The Company has completed the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members/ list of beneficiaries as on 9th February, 2018.
 - 2.2 The Company or its Share Transfer Agent has received ballot forms up to 5.00 p.m. (IST) on 22nd March, 2018, the last time and date fixed by the Company.
 - 2.3 As on the date of this report, no envelopes containing postal ballot forms were received after 22nd March, 2018, 5.00 p.m. (IST).

The votes cast were unblocked in the presence of two witnesses, Ms. Mittal Gori and Ms. Nancy Napoleon who are not in the employment of the Company.
